





Figure 7: Order of precedence of Assiniboine River water rights licenses







Figure 6: Reaches and water resource structures of the Assiniboine River

The Water Rights Act regulates all water rights licenses in Manitoba for all water sources. Concerns over the precedence of water users during low flows on the Assiniboine River were raised during the course of this project. The Water Rights Act states in Section 8(1):

Licences have precedence in relation to one another according to the date of submission of the application for each licence.



Temporal Precedence Grouped by Purpose of Use for Reach 1








Figure 10: Order of precedence of Reach 3 water rights licenses



Assiniboine River Water Supply and Demands (circa 2010)
















Option #1 Factor In The Return Flows

Under The Water Rights Act?



Section 8(1) of The Manitoba Water Rights Act reads:

Precedence of Licenses

8(1) – Licenses have precedence in relation to one another according to the date of the submission of application for each license.

FITFIR – First in time, First in Right

[First come, First Served]



What About Section 9?

Priorities

- 9 The order of priority of the <u>purpose</u> for which water may be used or diverted, or works constructed, established and maintained, in accordance with this Act is as follows:
- 1) Domestic Purposes (< 25,000 L/day)
- 2) Municipal Purposes
- 3) Agricultural Purposes (> 25,000 L/day)
- 4) Industrial Purposes
- 5) Irrigation Purposes (> 25,000 L/day)
- 6) Other Purposes



In Manitoba these <u>Use Purposes</u> may be used to effect <u>equity</u> in the following manner:

- 1) To <u>discriminate</u> among competing applications for water rights licenses
- 2) To <u>reserve water</u> for one or more preferred uses in the future
- 3) To <u>facilitate transfer</u> of water use from lower to higher preferred use categories
- 4) To allocate water during <u>drought</u> or other water emergencies



<u>Section 8(4)</u> of the WRA allows the agency to <u>discriminate</u> among competing applications for water rights licenses:

Where submission dates are identical

8(4) – Where the date of submission...in respect of any licence is identical ...in respect of any other licence, the licenses have precedence in relation to one another according to the priority of purpose established for each licence in the order of priority prescribed in section 9.



Section 13(1) of the WRA allows the minister to <u>reserve water</u> for one or more preferred uses in the future:

Reservation of Water

13(1) – Not withstanding any other provisions of this Act, the Minister may reserve any unlicensed water

(a) in order that a survey be made as to how the water may be used or diverted to the greatest advantage of the residents of the province; or

(b) for each uses and purposes specified by the Minister as in his opinion will be of the greatest advantage to the residents of the province;

And may fix a period of time within which the reservation may be utilized



Section 14 of the WRA facilitates the transfer of water use from a lower to higher preferred Use Category:

Cancellation of Licence

14(1) Where a person applies to the minister for a licence to use or divert water at any place or point and all the water available for use or diversion at that place or point has already been allocated to other licensees, if the purpose for which the applicant will use the water is higher in priority in the order of priority established therefor under section 9 than that of the purpose of one or more of those other licensees, the minister may issue the licence to the applicant and, subject to section 19, may cancel or restrict the rights under the licence of any one or more of those other licensees ranking lower than the applicant in priority of purpose.



Compensation

14(2) A person whose existing licence is cancelled or whose rights under his existing licence are restricted under subsection (1) in favour of a new applicant for a licence is entitled to receive from and shall be paid by the applicant compensation for any loss or damage suffered by him as a consequence of the cancellation or restriction.



<u>Section 19</u> allows the Minister to Re-allocate water during <u>drought</u> or if it is in the <u>Public Interest</u> to do so:

<u>Suspension and cancellation of licence</u> 19(1) – In addition to any suspension or cancellation of a licence that may be authorized under any other provision of this Act, the minister or a person authorized by him in writing may, for cause;

(a) <u>suspend a licence</u> or permit for any stated period of time or until a condition is met;

(b) where in the opinion of the minister it is in the <u>public</u> <u>interest</u> to do so, <u>cancel a licence</u> or permit whether or not it has first been suspended under clause (a).
